#### CHAPTER TEN

#### MODEL SCALE 1 GRADES

(This Chapter contains the recommendations for grades remunerated on Model Scale 1)

10.1 At present, the pay scales of Model Scale 1 grades are broadbanded into four segments: Senior Artisan, Artisan, Workman I and Workman II. In the Second Report, we recommended that the grades in the Senior Artisan and Artisan segments should be transferred to the Master Pay Scale, and that the existing Model Scale 1 should be revamped completely for the remaining grades in the Workman I and Workman II segments. Moreover, the benchmark for Workman II grades should have a value identical to that for Group I of the School Certificate Grades. We have therefore constructed a new Model Scale 1 which is shown in Table A at the end of this Chapter.

## Salary Structure

10.2 We have continued to adopt the existing broadbanding approach for Model Scale 1 grades. That is to say, all grades are given a pay scale corresponding to either the Workman I segment or the Workman II segment, with no further fine-tuning. Relevant job factors, if any, are reflected in the placement of the grade in a suitable segment or recognised by the payment of job-related allowances. Having regard to the job weight of grades in the respective segments and the results of the Pay Comparison Surveys, we propose the following pay scales for the Workmen I and II segments:

### Working Hours

10.3 At present, the conditioned working hours for Model Scale 1 staff are 45 hours net (i.e. excluding meal breaks) per week, due mainly to operational requirements. We note that comparable employees in the private sector generally work 45 hours net or more per week and recommend that the conditioned working hours of Model Scale 1 staff should remain unchanged. The proposed new pay scales have taken this into account.

# 10.5 Workman II

This is the only grade in the Workman II segment. Its pay scale should be revised to new MOD 1-3.
